Dear Tribal Health Leader,

On behalf of the Department of Health and Social Services (DHSS), I am writing to inform you of a proposed future Medicaid state regulation change that may result in an amendment to Alaska's waivers to provide home and community-based services under 1915(c). In keeping with DHSS's responsibility to conduct tribal consultation for amendments to waivers, this letter is being written as a courtesy, in conjunction with public notice for regulations change. It has yet to be determined whether or not this regulation change will result in an amendment to Alaska's 1915(c) waivers.

The proposed regulation changes include changes to 7 AAC 130:

#### 130.229. Use of restrictive intervention

• Enhances the health and safety of recipients by adding "chemical restraint" to prohibited forms of restrictive intervention that may be used to control recipients.

#### 130.250. Adult day services

 Improves access to supportive services by increasing the maximum number of hours per day a recipient may receive adult day services.

# 130.265. Residential habilitation services

• Restricts "in-home support" to a maximum of 18 hours per day; this is a "habilitative" service not appropriate for the full-day or overnight needs of recipients.

### 130.270. Supported employment services

- Controls utilization by restricting pre-employment services to a lifetime maximum of three months.
- Controls utilization by clarifying that transportation can be billed as part of supported employment services only if the recipient is engaged in paid work, and there are no other available options for transportation.

#### 130.275. Intensive active treatment

 Improves access to intensive active treatment by adding Special Education teachers to those qualified to provide the services. Tribal Health Leader May 28, 2014 Page 2

# 130.290. Transportation services

 Improves access to transportation services by allowing transportation providers to use employeeor volunteer-owned vehicles.

Any amendments resulting from these proposed changes are not expected to significantly impact tribal health providers or the Indian Health Service. Alaska Natives and American Indians may be impacted to the same extent as other Alaska Medicaid recipients.
