- 2. Mental Health Physician Clinics (MHPC) may only bill for services marked with an asterisk (*) in the Procedure Code/Modifier column.
- 3. Telemedicine services provided require a procedure code modifier to designate the type of telemedicine service. The modifier "95" indicates audio and video while the modifier "FQ" indicates audio only. When multiple procedure code modifiers are used, providers should report them with a single procedure code. For example, "90847-U7-95" indicates family psychotherapy with the patient present for 30 minutes via telemedicine with both audio and video in use.
- 4. Department of Health, Division of Behavioral Health rate charts do not cover all services reimbursed by Medicaid. If there are questions about services in this chart or services not covered in this chart, controlling regulation should be consulted. Regulatory payment restrictions such as payment limits, coverage limitations, mutually exclusive restrictions, or service authorization requirements are not fully addressed in this chart.
