

## **Alaska Section of Epidemiology**

### **Reporting sexually transmitted infections (STI), human immunodeficiency virus (HIV) infection, and acquired immunodeficiency syndrome (AIDS)**

#### **REQUIRED STD CASE REPORTING (WITHIN 2 WORKING DAYS)**

- **Chlamydia** (*Chlamydia trachomatis*)
- **Gonorrhea** (*Neisseria gonorrhoeae*)
- **Syphilis, all stages** (*Treponema pallidum*)
- **Chancroid** (*Haemophilus ducreyi*)
- **\*Mpox** (*Monkeypox virus*)

In addition to case reporting, reporting care team should:

- Assess all patients for risk, including social and sexual histories.
- Offer expedited partner therapy for sexual partners with chlamydia and/or gonorrhea exposure.

HIV/STD Program personnel are available to assist with case review and confidential partner notification. Prompt partner identification, notification, diagnosis, and treatment are essential to prevent STI and HIV transmission.

#### **REQUIRED HIV/AIDS CASE REPORTING (WITHIN 2 WORKING DAYS)**

- **Any human immunodeficiency virus (HIV)**
- **Any acquired immunodeficiency syndrome (AIDS)**

Health care providers are required to report all suspected or confirmed cases of HIV infection.

- Suspected cases may include patients with a reactive HIV rapid/point-of-care test; patients who self-report as a person living with HIV (PLWH); PLWH who are newly accessing Alaska HIV care services who were first diagnosed in another state or country.

Health care providers are required to report all suspected or confirmed cases of acquired immunodeficiency syndrome (AIDS/Stage 3 HIV Infection) for all patients with confirmed or suspected HIV infection.

- AIDS is defined as clinical diagnosis (presumptive or definitive) of certain opportunistic infections or a CD4 cell count of  $\leq 200$  cells/mm.

#### **PREGNANCY STATUS**

Healthcare providers are required to report the following:

- Any new pregnancy in a person living with HIV (PLWH)
- Any new pregnancy in a person with suspected or confirmed syphilis infection
- Pregnancy status of all persons with a reportable STI
- Pregnancy status of all persons with suspected or confirmed HIV infection
