VacTrAK Forecast Issues

This is a known forecasting issue with meningococcal MCV4P/MenACWY: If meningococcal vaccine is administered at 10 years of age, VacTrAK incorrectly forecasts another dose at 11 years of age. Meningococcal (MCV4P/MenACWY) vaccine should be counted as part of the routine 2-dose series, if administered at 10 years of age; the next dose should be received at 16 years of age.

The recommended schedule for meningococcal vaccine is at 11 years and the second (booster) dose at 16 years for adolescents.

Dear Izzy

This is a new section of the newsletter that highlights questions from the Immune Helpline.

Dear Izzy,

In the vaccine forecast section of VacTrAK, I noticed the status of one of the vaccines said "Optional". What does that mean? –MN

MN,

Thank you for the great question! "Optional" in the forecast means that a particular vaccine has met the minimum interval to be given. This is where you would use your clinical judgement for that particular patient. If this patient will not return for the recommended interval you may want to recommend that they receive the vaccine at this visit. Dear Izzy,

I had a patient come into the clinic for a flu shot. They have had a flu vaccine every year for several years. When I reviewed their VacTrAK history, they had received two flu shots this season, and VacTrAK is forecasting that they are due again. I did not give them a shot during their visit. Should I have given them a third shot? –KP

KP,

Great clinical thinking by not given them that third shot. Sometimes VacTrAK can have errors with forecasting. You should always use your clinical judgement when reviewing the data used for administering vaccine.
