
# **MARRIAGES & DIVORCES**

## MARRIAGES

There were 5,246 marriages performed in Alaska in 2003, involving 4,505 Alaska resident brides and 4,534 Alaska resident grooms. The number of marriages in 2003 was 1.7 percent lower than the 5,336 marriages that occurred in 2002. The crude marriage rate in 2003 was 8.1 marriages per 1,000 residents, down from 8.3 marriages per 1,000 in 2002.

Crude marriage rates (the number of marriages occurring in a census area or borough per 1,000 residents) vary widely in Alaska. For instance, the lowest rate of 1.5 marriages per 1,000 residents was in the Aleutians East Borough. The highest rate of 18.8 marriages per 1,000 residents was in Denali Borough. Locations that are popular tourist destinations (such as Denali National Park) may have higher marriage rates because non-resident couples travel there to get married.

There were 543 marriages in which neither the bride nor the groom was a resident of Alaska, a 1.9 percent increase from the 533 nonresident marriages in 2002. The Juneau Borough had the largest number of nonresident marriages in 2003 with 181, which accounted for 47.6 percent of all marriages occurring in Juneau. The Municipality of Anchorage had the second greatest number of nonresident marriages with 126.

## **DIVORCES**

There are three administrative methods for terminating a marriage in Alaska: divorce, dissolution, and annulment.

Divorce is an adversarial process in which the terms of the decree are decided by the courts based upon evidence, testimony, and in accordance with Alaska statutes. These terms include disposition of property, living arrangements, and custody and support for any minor children involved. In 2003, there were 998 divorces granted in Alaska. This represents a 2.9 percent decrease from the 1,028 divorces granted in 2002.

A dissolution of marriage is a cooperative agreement between the husband and wife in which both parties agree to the terms for distribution of property, living arrangements, and support and custody of minor children. The agreement is reviewed by the court, which can amend it if it determines the terms are not equitable.

In 2003, there were 1,828 dissolutions of marriage in Alaska. This is a 3.4 percent decrease from the 1,893 dissolutions reported in 2002.

An annulment is a judicial pronouncement declaring In 2003, there were six a marriage never existed. annulments granted in Alaska, which is four less than reported in 2002.

There were 35 instances in which the type of decree was not specified. When not otherwise stated, the term divorce refers to all methods collectively.

In 2003, the total of 2,867 divorces, dissolutions, and annulments resulted in a crude divorce rate of 4.4 divorces per 1,000 population, compared with 4.6 in 2002.
