2016 Alaska Resident Drug Overdose Outpatient Visits and Inpatient Hospitalizations

The Alaska Facts and Figures tables were prepared by the Alaska Department of Health and Social Services, Division of Public Health, Health Analytics and Vital Records Section. These tables summarize outpatient and inpatient discharge data from the Alaska Health Facility Data Reporting (HFDR) program for hospital discharges during 2016.

Additional Information

- The statistics provided in the tables reflect data based on hospital inpatient discharges for Alaska residents. Alaska hospitals are required to report their discharge data to the State of Alaska (7 AAC 27.660).
- These tables provide discharge counts and rates separately for outpatient and inpatient drug overdose discharges.
 - The ICD-10-CM diagnoses codes for poisoning by medicines or drugs (codes T36-T50) are grouped into 3 categories in the tables: "All Drugs," "Heroin" alone, and "Opioids (excluding Heroin)."
 - The "Heroin" discharges and the "Opioids (excl. Heroin)" discharges are also counted in the "All Drugs" category.
 - The discharge counts include drug overdoses coded in the principal or secondary diagnosis fields.
 - These discharge counts include initial and subsequent encounters.
 - Rates are listed as occurrences per 100,000 population, and the population estimates used are for people residing in Alaska on July 1st of the discharge year.
- The discharge counts are not mutually exclusive. For instance, if the principal diagnosis or any of the secondary diagnoses for a single discharge include both a heroin diagnosis and a non-heroin opioid diagnosis, the discharge would be counted in both categories. Also, an individual patient might be counted more than once within a category if they have multiple drug overdose discharges in the calendar year.
- These tables reflect the latest and most complete counts of hospitalizations. The data presented may differ from previous tables or reports due to late or corrected data submission to HFDR.
- The drug overdose counts do not include discharges for the toxic effects of alcohol.
- The data are stratified by Sex, Race, Age Group, and Regional Area (Public Health Region).
- Any rate based on fewer than 6 events is not reported, and any rate based on fewer than 20 events is statistically unreliable and should be interpreted with caution.
- Age-adjusted rates were adjusted by year 2000 standard population ratios. For more information see the Healthy People Statistical Notes on <u>Age</u> adjustment using the 2000 projected U.S. population, January 2001.
- The single-race population estimates used to calculate rates in these tables are provided by the Alaska Department of Labor and Workforce Development, Research and Analysis Section, Demographics Unit.
