

ALASKA HEIRLOOM MARRIAGE GIFT CERTIFICATE REQUEST FORM INSTRUCTIONS

PLEASE READ THESE INSTRUCTIONS CAREFULLY

This form is **ONLY** to be used for purchasing gift certificates for Heirloom marriage certificates.

Incomplete applications will be returned unprocessed.

You do not need to include a photocopy of your ID when ordering a gift certificate.

How to submit a request:

- Complete this form and submit it via mail, fax, or in-person. (Addresses, hours and fax number are listed below)
- Include payment via check, money order, or by providing your credit card information at the bottom of the request form.
- Choose **one** method of submission. Please be advised that if you submit your requests via more than one method, you will be charged for each request.

Processing times:

- Heirloom gift certificate requests are normally processed within 4 – 6 weeks after receipt by Alaska Vital Records. Note that most governmental agencies do not accept heirloom certificates as proof of marriage.
- Normal processing times can be greater during periods of high volume.
- Please allow mailing time.

Fees:

- The first gift certificate for an heirloom marriage certificate is \$65.00 and additional gift certificates are \$60.00 for each copy of the same record ordered at the same time.
- All NSF checks will be sent to a collection agency. There will be a \$30.00 charge for returned checks.
- Thirty-five dollars (\$35.00) of the heirloom gift certificate fee goes to the Alaska Children’s Trust. The mission of the Trust is to improve the status of children in Alaska by generating funds and committing resources to eliminate child abuse and neglect. All fifty states plus the District of Columbia have Children’s Trust Funds. For more information about the Alaska Children’s Trust contact:

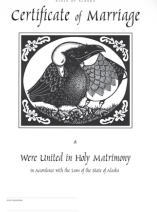

- Please read the instructions on the previous page. **Incomplete requests will be returned unprocessed.**

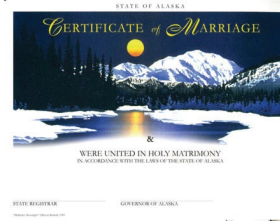
