Produce Mapping - Made easier

All WIC approved produce must be mapped to a PLU code listed in the APL, including produce items with UPCs

Why Produce Mapping specifically?

- Mapping makes new produce items immediately available for WIC purchase
- UPCs and PLUs for fresh produce are constantly changing
- If an item isn't on the APL, it cannot be purchased with WIC benefits.
- There is no "**OVERRIDE**" in eWIC.
