### THERE ARE CURRENTLY NO ACTIVE **OUTBREAKS INVOLVING WIC-APPROVED** PRODUCTS

However, please be aware of the following recent outbreak:

#### **Outbreak Investigation of Salmonella:** Eggs (June 2025)

Do not eat, sell, or serve recalled chicken eggs distributed by August Egg Company. The FDA's investigation is ongoing.

# **Zero Substitutions** Allowed!

Items provided to shoppers must match the barcode, Universal Product Codes (UPCs), or Product Lookup Codes (PLUs) entered/scanned at the cash register. Receiving reimbursement for foods not provided to the WIC shopper is considered fraud of a federal assistance program and can be reported. Additional penalties may include termination, disqualification, civil money penalties, and criminal prosecution. \*Note that manually keyed entries are flagged in our system to assist in detecting fraudulent activity. Please also refrain from entering card numbers by hand at either your stand-beside or integrated system.

**Management: Remember to check** your Store's email for State of Alaska–WIC Vendor updates!!!

As outlined in the WIC Vendor Agreement, it's important to regularly check for communications from the State of Alaska WIC Vendor team. It is also the Vendor's responsibility to notify us of any updates or changes in store contact information. Thank you for doing your part to support strong, timely communication. We appreciate it!
