

AKAIMS Minimal Data Set Quick Guide

Required Fields in AKAIMS for Minimal Data Set reporting:

This is a list, mostly in order of use, of required fields to meet Alaska's minimal data set for reporting to the state. It does not explain any of the fields or questions; it simply lists them.

Client List

1. Client Profile:

- First & Last Name
- Gender
- Maiden Name (if Gender is female)
- Date of Birth
- Social Security Number
- Medicaid ID*

2. Additional Information*

- Ethnicity*
- Races*
- Veteran Status*

**If client only receives Crisis Intervention/Crisis Stabilization, these are only required if known.*

Emergency Services (If applicable)

4. Substance Abuse **

- Primary Substance (plus for each substance:)
 - Frequency
 - Method
 - First use age
- Secondary (grays out if “none”)
- Tertiary (gray if none)

5. Legal

- # of Arrests in Past 30 Days

Diagnosis (auto-populates forward from BHA or Diagnosis screen)

- Primary (populates from Principal Behavioral diagnosis)
- Secondary (if applicable)
- Tertiary (if applicable)

Program Enrollment

- Program Name
- Start Date

The rest, not until enrollment has ended:

- End Date
- Date of Last Contact
- Termination Reason

Encounter Notes

1. Profile:

- Program Name
- Service
- Start Date
- Service Location (can be set to default)
- Start Time (only for duration-based services)
- End Time (only for d-b services)
- Duration (only for d-b services)
- Units (only for session-based services)
- Rendering Staff (defaults to logged-in user)

Discharge*

1. Profile:

- Date
- Reason

2. Tx Summary **

- Did Client Receive HIV/AIDS Risk Assessment
- Did Client Receive HIV/AIDS Risk Education

- Did Client Receive HIV/AIDS Risk Reduction Counseling
- FAS Education Given
- Hepatitis C Education Given
- TB Education Given
- Referral for TB Testing

**Only applies to clients who are admitted. If no admission occurs, the case is closed on Intake screen.*
