

**Home and Community Based Waiver and Personal Care Target Provider
August 1, 2024 List**

Each August 1, per 7 AAC 145.531(b), the Department will publish a list of target providers on the department's website and on the Alaska Online Public Notice System. Providers identified on this list will be required to submit an annual report within 8 months of their fiscal year end for the fiscal year that ends during the calendar year in which the list is published. The Department will list if the annual report is a full annual report or a reduced annual report.

Report Type: Reduced Annual Report for all listed providers (7 AAC 145.531(d))

Report Due Date: 8 Months after FYE

The August 1, 2024 list was determined by using claims data for dates of services July 1, 2022 through June 30, 2023, which represents the most recent state fiscal year for which timely filing has passed. Target providers are determined by the Medicaid units of service that were paid during the applicable time period. For each service category, the lessor of the top five providers in terms of units of service or the number of providers it takes to achieve 80% of all Medicaid paid units of service are selected.
