Dear Tribal Health Leader,

On behalf of the Department of Health and Social Services (DHSS), in keeping with the DHSS responsibility to conduct tribal consultation, I am writing to inform you of a proposed future Medicaid State Plan Amendment (SPA). *This letter of consultation is written in conjunction with public notice for a regulation change.*

Durable Medical Equipment, Orthotics, Prosthetics, and Supplies (DMEPOS): Proposed amendment will result in conforming program rules to adopt Medicare fee schedule as required under 42 USC 1396b(i)(27). The impact of the proposed revisions to the reimbursement rate for individual DMEPOS code will vary by code. Some of the other changes include revising enrollment requirements and payment coverage for covered items and services; payment for used or refurbished equipment; amending the list of non-covered items and services; transitioning to a capped rental system; further defining prior authorization requirements.

The changes set certain limitations, but may concurrently improve access in other areas for IHS recipients. The impact is anticipated to be nominal as no IHS or tribal health entities are enrolled with Alaska Medicaid as Medical Suppliers to dispense Durable Medical Equipment (DME). The state does not anticipate that IHS recipients will experience any significant impact because of the changes.
