# **IMPROVE AFFORDABILITY & SUBSIDY PROGRAM \$28,657,319**

#### **Funding source- ARPA:**

- Hire a contractor to review and improve the Child Care Assistance Program to make it more accessible and supportive for parents and providers which will inform strategies such as: \*\*\*
  - Support parents by covering the cost of co-payments (for a period to be determined)
  - Provide grants to families not typically covered by child care assistance including those utilizing non-traditional care hours and those ineligible due to income, this will be targeted to parents working in the first responder and/or medical fields
  - o Increase reimbursement rates to a higher percentile of market rate
  - Improve payment polices
  - Broaden eligibility to child care assistance
  - o Update Family Income and Contribution Schedule
  - Provide contracted slots
  - o Improve Child Care Grant Program & the Alaska IN! Program
- Pilot a tiered reimbursement initiative for infant and toddler care \*\*\*
- Provide financial aid for providers who were not participating in subsidy system prior to Covid-19 pandemic\*\*\*

#### **INCREASE ACCESS TO LICENSED CARE \$45,336,010**

#### **Funding source- ARPA:**

- Phase 1 stabilization provides immediate relief to providers and collects information to inform future phases\*\*\*
  - Additional supports through bonuses provided for non-traditional care hours (designed to serve parents working in the first responder and/or medical fields), Learn & Grow participation, Child Care Assistance Program Participation, serving children with special needs, and serving infants and toddlers.
- Phase 2 stabilization helps providers reach their intended licensed capacity and return to stabilization\*\*\*
  - Additional supports through bonuses provided for participation in Learn & Grow and the Child Care Assistance Program
- Additional Phases will have built in stabilization practices and requirements

  - o free training for providers through thread \*\*\*
  - Utilize one time funding to finalize full implementation of Learn & Grow, Alaska's
    Quality Recognition and Improvement System\*\*
  - Utilize SEED professional development system funds to implement Alaska's Early Childhood Strategic Direction strategies for supporting the workforce \*\*\*
  - Provide funding to Individuals in the field through SEED ROOTS awards\*\*\*
