Influenza Update

Due to the COVID-19 pandemic, the Alaska Immunization Program is waiving eligibility limitations for adults for influenza vaccine for 2020-21. For certain influenza vaccines, all adults and all pediatric patients are eligible regardless of insurance status.

Eligibility <u>MUST</u> still be tracked for dose-level accountability. Adult patients who meet an "Ineligible" category (i.e. Medicare, Medicaid, VA, insurance that doesn't cover vaccines) must be marked as that eligibility but then can receive the state-supplied influenza vaccine.

Utilize VacTrAK for the 2020-21 Influenza Season

Ensure a successful influenza vaccination season. VacTrAK gives access to many reports and tools that can assist in reaching the goal of greater coverage for this 2020-21 season.

- Guarantee your stock levels can meet demand. Use last year as a guide but increase orders to meet 2020-21 goals.
 - Inventory Transaction Report will provide a history of public vaccine orders from previous season
 - Select all influenza vaccines, public funding and date range of 8/1/2019 to 6/30/2020
 - Vaccine Administered Report will provide last season's reported administration (public only, private only or both public and private)
 - Select all influenza vaccines, funding choice, and date range of 8/1/2019 to 6/30/2020
 - Be proactive and reach out to patients through <u>Reminder Recall</u> activities
 - Assess progress throughout the season with the Coverage Rate Report (Child Coverage Rate / Adolescent Coverage Rate)

Perinatal Hepatitis B Prevention Program

There are many challenges pregnant women experience when it involves protecting their infants. Recently announced by CDC was updated guidance on how to prevent hepatitis B mother-to-child transmission in the midst of a COVID-19 pandemic.

To ensure that certain safety nets are in place, this guidance is provided. We must work together to prevent mother-to-child

hepatitis B virus (HBV) transmission in the event of significant COVID-19 pandemic-related disruptions in routine preventive services before, during, and after labor and delivery. The guidance is intended to be used by obstetric and pediatric care staff for consideration while prioritizing the Advisory Committee on Immunization Practices (ACIP) recommendations for prevention of mother-to-child transmission of HBV infection (see https://www.cdc.gov/mmwr/volumes/67/rr/rr6701a1.htm).
